These sons Samuel and Anthony sold their interest Jany 21, 1717 to Francis and Anthony Thornton the plaintiffs. Thomas Pannell died leaving issue a son and two daughters: 1 William, 2 Mary, who married Francis Stone, 3 Isabella, who married Richard Phillips, and died after her father and left a daughter Catherine who married John Knight. John Knight and Catherine, his wife, made a deed 24 March, 1705 to Francis and Anthony Thornton.

John Buckner devised land to Thomas Buckner, one of the defendants, and Richard Buckner was the other defendant.

Page 35. April, 1730. Marston vs Parrish. Detinue:

mond and begin with the year 1623. These patents serve as the chief source of information covering the early inhabitants and their locations.

The first Palmer of record in Virginia can quite accurately be said to be Thomas Palmer who came over from England in the ship "Tiger" in 1621 with his wife Joane and daughter Priscilla, age 11 years. On Feb. 16, 1623, these three are given as residing in Virginia at "Jordan's Journey," which is probably just below City Point. This Thomas was a member of the House of Burgesses of the Colony which assembled at Jamestown Oct. 16, 1629, and he represented Shirley Hundred Island. He was also a member again on Mar. 24, 1629/30 from Shirley Hundred Main. He was commander of a company of Shirley Hundred men and was called Captain. He was a Justice appointed in Mar. 1631/2 for the monthly courts for the upper parts of the counties of Charles City and Henrico. Jane and Priscilla appear in Charles City County in 1637 as head rights under John Baker as patentee. Whether Thomas had died by 1637 we do not know, nor do we know whether he had any other children. He could have had others, but none appear of record.

Edward Palmer of York Co. is without doubt the one who came in the ship "Friendship" in 1629. He was probably quite young at this time, around twenty, and could have been the son of Thomas above, but there is nothing to indicate this relationship. Edward is found in York Co. on a coroner's jury in Mar. 1660 and on June 4, 1658 he was granted 400 acres at Puscataway Neck for transporting eight persons. Richard Palmer was granted 223 acres on Apr. 26, 1684, formerly patented to Edward Palmer, deceased, for five head rights. From these and other records in York Co. we have considered that Edward was a first ancestor of a Virginia family and left at least three children, to wit. Richard, James and Thomas. Descendants of these three sons continued to reside in York Co. for several generations, while others of this family moved to the upper and western parts of Virginia and into North Carolina.

Martin Palmer of King William County with wife Mary appear first in 1653 with Joseph Croshaw as patentee. He was born about 1625 in England. He soon became quite important in the colony and brought over as patentee a large number of persons. In 1658 he received a grant of 1300 acres in New Kent Co. and again other grants in 1661 and 1665 for transporting persons. His wife Mary died and he married three more times and died about 1702, leaving as far as we have been able to ascertain only one son, Martin Jr., whose birth is given as 1660. Martin Sr. was called Captain and later Major, and is first found in the records of York Co., then New Kent Co., and later in King William Co., but probably resided nearly all the time in King William Co., as this county was taken from New Kent and New Kent from York Co. Martin Jr. in turn lived in King William Co. and died by 1717, and had children, to wit. Martin, Roger, James, Charles and probably others. This Martin 3d is undoubtedly the one who moved about 1750 to Charlotte Co., Va., and established a family there and in the adjoining counties. This family in time extended in many directions, into Ohio, Missouri, Texas, Alabama, Tennessee and the far west. The name Martin has been handed down through the generations to the present time. The son James went to South Carolina and left a family in that state and Georgia. The son Roger probably left a family in Virginia, as did also the son Charles. There are several families in Virginia that trace back to King William Co.

#### GOOCH FAMILY.

The name Gooch appears under the form of Gooch, Gouge, Gough, and Goffe.

William Gooch lived near the present site of Yorktown. In November, 1654, Capt. William Gooch represented York county in the House of Burgesses, and March 31, 1655, he was one of the councillors appointed by the General Assembly. He died the following October, aged 29. *Burke's Peerage and Baronetage*, edition of 1896, gives a William Gooch, uncle of the Governor of Virginia of that name, as having died in 1655. He may have been this William Gooch, who became a major after his appointment as councillor. William Gooch, of York county, left a daughter Anne, who married Capt. Thomas Beale. He probably left a son William,

as Hening (Vol. II, p. 158) tells of a difference between Martin Palmer and John Prosser, who "married the relict of William Goffe," about 1,000 acres in New Kent, granted by patent to "Capt. Palmer, and by a later patent to William Goffe, son of William Goffe, deceased."

In the York county books Henry Gooch, called "brother" of Major James Goodwin, was supervisor of the estate of Major William Gooch. On the death of Robert Kinsey, he married, about 1661, Millicent Kinsey, the widow. Henry Gooch was justice of York county, and became lieutenant-colonel. He took sides with Bacon, and Mrs. Ann Cotton tells of a severe retort made by the commander upon him. When Bacon met the men of Gloucester county at the court-house, he got out of patience with their lukewarmness, and offered to go away. "Col. Gouge" tried to compromise things by calling out to Bacon "he had only spoke to the Horses (meaning the troopers) and not to the foots." Bacon testily replied, "he had spoke to the Men and not to the Horses, having left that servis for him to do, because one beast best would understand the meaning of another." When the revolt died out, the last meeting of Lawrence and the rest was held at Col. Gooch's house in New Kent (probably in that part now King William). In 1676-'77 he was fined 6,000 pounds of tobacco and pardoned, on his bended knees, by Sir William Berkeley. This is all that is known of him. (See *Force's Tracts* and *Hening's Statutes*.) Rev. John Gough was minister at Jamestown during this time, and he died January 15, 1682. He married at least twice, and had by first marriage William Gough (Gooch). He married, secondly, Jane, sister of Rev. Rowland Jones of the neighboring parish of Bruton, and her issue mentioned in the latter's will were "Henry, Rowland, Jane, and Elizabeth Gooch."

There is a patent to William Gough for 1,225 acres in King and Queen on Papettico Swamp, formerly the land of "Mr. John Gough," and since granted October 26, 1694, to William Gough, as "son and heir" to his father. In the same neighborhood there is a grant to "Mrs. Jane Gouge." Her will is on record in King William under the name of "Joane Gough," and bears date February, 1704. It mentions sons Henry and Rowland Gough, daughter Joane Peake, and son-in-law William Gough. On July 17 following, Henry and Rowland Gough qualified as executors. William Gough (Gooch, Gouge), the "son-in-law" (the term then meant *stepson*), married Ursula Claiborne, daughter of William

Claiborne (grandson of Secretary Claiborne), and had issue Claiborne Gooch, eldest son. (*Virginia Magazine of History and Biography*, Vol. II, p. 818.)

Claiborne Gooch was living in 1748 in King William county, opposite to Sweet Hall. (Hening, VI., p. 17.) He was probably father of Rowland Gooch, whose will was proved in Louisa county December 8, 1794. Rowland's wife was Unity ———. He had issue: 1, William; 2, Claiborne; 3, John; 4, Rowland; 5, Lanea; 6, Elizabeth. In the same records is a deed of gift from Luvinah, wife of William Gooch (will proved 1780), son of Rowland, to her daughters Mary, Jamimah, and Sally Gooch.

Sir William Gooch, governor of Virginia from 1727 to 1749, was born October 12, 1681. He married Rebecca, daughter of William Stanton, Esq. He had one son, William, who married Eleanor, daughter of James Bowles, of Maryland, but as Sir William Gooch was succeeded in the baronetcy by his brother, there are no descendants of the Governor in Virginia. Governor Gooch died, according to one account, in 1751, and, according to another, August 14, 1759. (*Virginia Magazine of History and Biography*, Vol. III, p. 118.)

Gooch—Gouge—Goffe. I think I was in error in making Jane\*, daughter of Rowland Jones, minister of Bruton Parish, marry Rev. John Gough, of Jamestown. I am now sure that there was no such minister as Rev. John Gough, dying in 1683-'84. A close inspection of the tombstone at Jamestown satisfies me that the name of the minister was John Clough. A person of that name was minister of Southwark Parish, on the opposite side of the river, in 1680. "John Goffe, of New Kent, Gent.," made a deed in York county as late as September 23, 1685, to his son William Goffe, in view of his son's intended marriage with Elizabeth Dixon. The signature differs from the preamble of the deed, being "John Gough." Lieutenant-Colonel Henry Gooch lived in New Kent, and must have been the husband of Jane Jones, a supposition confirmed by her naming a son Henry. William Gooch, or Gough, or Gouge, who married Ursula Claiborne, is named "son-in-law" (step-son) by Jane Gooch, and was probably a son by Henry Gooch's marriage with the widow Millicent Kinsey.

## GOFFE - PROSSER - KENDALL of ESSEX

William Goffe, immigrant ancestor of this family, patented 1000 acres in New Kent, Oct. 7, 1658, for the transportation of 20 persons. (C.P. 380) This land was on the N.E. side of the Mattaponi River. (C.P. 496) On Feb. 18, 1663, his wife, Martha Goffe patented 650 acres of land in the same locality, "formerly granted to William Goffe July 22, 1659, assigned unto John Madison who assigned same to said Martha". (C.P. 496)

After the death of William Goffe his widow married John Prosser, immigrant ancestor of this family, who patented 200 acres Feb. 21, 1663, joining upon land formerly William Goffe's. (C.P. 440) Martha Goffe died before Aug. 28, 1673, for that was the date her second husband, John Prosser, made his will which was probated June 6, 1677. (Sweeney-55) He stated that he was of "Golden Vale, in the Parish of Sittingbourne in the Freshes of Rappahannock Co.", desire to be buried by the side of first wife Martha. His legatees were "now wife, Margaret, 500 acres of land,  $\frac{1}{2}$  of moveable estate, and plantation of Golden Vale for life, then to eldest son, John Prosser; to son John also, plantation called Nutgrove; son Samuel Prosser 400 acres adjoining; to sons Roger and Anthony a dividend of 1100 acres upon Mattaponi Swamp. Sons in law Robert and Thomas Goffe to have jointly 200 acres adj. Golden Vale. Sons are under 18. Wife, Margaret, extrx., to be assisted by James Kay.

Margaret Prosser, widow of John Prosser, married secondly Captain Symon Miller, immigrant ancestor of the Miller family. On April 4, 1669, John Prosser deeded to Captain Miller 1000 acres of land on the Rappahannock. (D.B. 1668-72, p. 134) Captain Miller in his will dated Feb. 16, 1679, proven May 22, 1684, gave his wife's son, ANTHONY PROSSER a male foal. (Sweeney-92)

Martha Goffe, dau. of Martha and Thomas Goffe, married first, according to the notes of Judge Embrey, Charles Kendall and then Thomas Kendall. On Aug. 19, 1670, John Prosser deeded to MARTHA, only daughter of his deceased wife, Martha Prosser, now the wife of THOMAS KENDALL, 300 acres adj. George Sheperd, on south side of Rappa. River. (D.B. "V", p. 200) (In 1692 this land fell in Essex County)

On March 24, 1694, Thomas Kendall and wife, Martha, of St. Mary Parish, Richmond Co., sold this 300 acres to Charles Taliafero for 8000 lbs. Tlco. (Essex BK. 0-301) They had evidently moved north of the Rappa. River and lived on the land, 105 acres, patented by Thomas in 1697 adjoining Grimstead and THOMAS GOFFE (N.N.G.B. 1694-1700)

## THE KENDALL FAMILY

Thomas<sup>1</sup> Kendall, ancestor of this family, came to Kent Island on the ----- in 1631 which was the year Captain William Claiborne colonized that Island. (See Claiborne and Butler, V.H.G.) He was one of Claiborne's men and served there 1631-36. Thomas Kendall, with John Sturman and Thomas Youell, moved from Kent Island in 1636 to St. Marys because of Lord Baltimore's disturbance of William Claiborne. (Sturman notes, W. & M. Quart. No reference given) Thomas Kendall died about 1646. His will, was dated Nov. 9, 1646, no county shown. He gave personalty to the son of Roger Baxter of Kent Island and leaves a trust fund for his three children, not named, under the guardianship of Thomas Youell with John Sturman as a witness. (Md. Mag. 28-181, 262) (Archives and Court Records) Roger Baxter in his deposition of 1660 states that they had moved to St. Marys as Puritans. A number of these Puritans migrated to Virginia. (See Butler V.H.G.) Thomas Sturman, his wife, a daughter and a son, John came from Hadman Parish Co. Bucks, Eng., on the "Sarah Ellis" in 1640 and Thomas Sturman died in 1654 in Westmoreland. In 1652 Thomas Youell received a grant in Northumberland and is mentioned as deceased in that county in 1655. No doubt but that he brought the Kendall orphans with him same as the Butler orphans were brought by John Hallows in 1650. (See V.H.G., p. 25) In fact John Hallows (Hollis) and his family were imported by a Thomas Hoskins who also brought over five members of the Youell family. (C.P. 315) John Hallows arrived on the "Ark & Dove" in 1635. (H.S.F. Vol. 1, p. 4)

Thomas<sup>2</sup> Kendall with Thomas Goffe and John Willis bought 405 acres of land March 7, 1687/8 in Rappa Co. which afterward fell in King George Co. The deed was from Mallary Peale of Stafford Co. and was witnessed by Lawrence Washington and Richard Lee. (D.B. 7-486)

On March 2, 1716-17, Thomas<sup>2</sup> Kendall of Parish of Hanover, Richmond Co., made a deed of gift to his son WILLIAM KENDALL and his now wife Elizabeth (dau. of John Combs) of that plantation of 50 acres where said Thomas Kendall now lives and whole personal estate to son William except what I have given to my youngest son, SAMUEL, provided that William live upon said plantation and maintain Thomas Kendall during his natural life. (D.B. 7-196)

### Children:

- I. Thomas Kendall Jr., married Abigail. He died before his father and was not mentioned in his above deed. Abigail Kendall, relict of Thomas Kendall, Jr., decd., petitioned for letters of Admn. on his estate June 6, 1716, which were granted. Benj. Strother and Joseph Minton, Sec. (O.B. 6, p. 5) She married secondly William Reed, who, in his will

dated Dec. 19, 1720, leaves wife Abigail, sons Sam and Thomas Reed and SON IN LAW SAMUEL KENDALL certain property but provides "that all property which formerly belonged to my wife and her children to remain their own." (W.B. 4-166)

II. William Kendall, m. 2nd Elizabeth Combs, whom her father, John Combs, in his will of 1717, Richmond, mentioned as his daughter, Elizabeth, wife of Wm. Kendall.

III. Samuel Kendall (See later)

Samuel<sup>3</sup> Kendall, son of Thomas<sup>2</sup>, lived in King George County. On Nov. 9, 1721, Wm. Kendall of Westmoreland deeded to his brother, Samuel Kendall of King George, for love and affection and 3000 lbs. Tlco. 50 acres of land part of a patent to Thomas Kendall of 105 acres given by Thomas to William Kendall being land whereon Samuel Kendall now lives. (BK. 1, p. 59) Samuel Kendall and Sarah, his wife, on June 3, 1741, then of Westmoreland Co., sold this land to Jeremiah Murdock. (D.B. 2, 376) Samuel died in Westmoreland, will dated Jan. 22, 1747, proven July 31, 1750. (Fothergill 128-129) His legatees were wife, SARAH, daus. ANN, MARTHA, MARY, GLADYS, ELIZABETH; sons MOSES (See later) and WILLIAM. FRANCES KENDALL, a daughter, was born in 1750 after date of father's will. The executors of Samuel's will were "cozen" (nephew) John Kendall and John Macormack. This John Kendall was a son of Samuel's brother, William Kendall. John m. (1) Frances Sharp, (2) Eliz. Frank in 1745. In his will 1754 in Westmoreland he left a legacy to Frances, dau. of William Kendall. (Id. 135)

Moses<sup>4</sup> Kendall, son of Samuel<sup>3</sup>, died in King George where his will was probated in 1793. His executors were sons WILLIAM and SAMUEL. Two-thirds of his estate were to be used for the schooling of his small children, the remainder of his estate to his wife, AMY.

The "small children" of Moses Kendall are shown in the will of their older brother, Samuel Kendall, Jan. 15, 1821, in Essex Co. He had married a widow, Mrs. Bundy, with a number of children to whom he left most of his property. He stated in his will: "I give a bond from Benjamin Kendall for \$12,000.00 to my mother, AMY KENDALL, my sisters AMY KENDALL; SALLY SPILMAN; BESTSY CARVER; brother THORNTON KENDALL and GEORGE KENDALL. I give a bond from John Kendall for \$8,000.00 to my brother JAMES KENDALL." (W.B. 19-165)

On May 28, 1821, for himself and as attorney for the other legatees named in the will of Samuel Kendall (except Thornton Kendall) gave a bond in the amount of \$4,000.00 to Nathaniel Mothershead, executor of will of Samuel Kendall of Essex Co., Va. (W.B. 19-245)

James Kendall went to Montgomery Co., N.C. about 1808, married about 1811 Mary Atkins Tomlinson, b. 1794, daughter of Thom. Tomlinson and Olive Hines who had other children -- Nancy Ann (Polly) m. Charles G. Gaines, James, Thomas H. Tomlinson m. Eliz. Ledbetter.

James Kendall and family lived in the Forks, Montgomery Co., N.C., owned land on both sides of Rocky River and island in the river. After death of his mother, Amy Kendall whose es-

William Strother, the first of Virginia, is said to have married Dorothy, daughter of his neighbor, Capt. Anthony Savage, but there seems to be no documentary proof of this. Old Rappahannock County was divided into Richmond and Essex in 1692, and William Strother made his will in Richmond County, "sick and weak" Oct. 2, 1700, probated Nov. 4, 1702. He bequeathed his "eldest son, WILLIAM STROTHER, 150 acres of land including plantation I live upon... except that while my wife Dorothy shall live she shall peacefully and quietly possess one half of said plantation, with housing, etc.; upon her death same is to return to son William", to son JAMES 150 acres next to William, the remaining part of my land to be divided between sons ROBERT and BENJAMIN; son JOSEPH to be put to school and to be free at his own disposing at age of 16; to grandson Will Strother 2100 lbs. tobacco to be sent to England and proceeds paid him at age of 10. All rest of my personal estate to my loving wife Dorothy, during time of her widowhood, but if she shall marry, said personal estate is to be equally divided between her and my sons JAMES, JEREMIAH, ROBERT, BENJAMIN and JOSEPH. Wits.: James Phillips, Edward Langdres, Wm. Smith.

Jeremiah Strother, son of William and Dorothy Strother, bought land from J. W. Smith in Westmorland in 1703 and he subsequently became a planter in King George when that county was formed from Westmorland. He later removed to Orange County in that part of the county which fell in Culpepper when it was cut off from Orange. However, he died in Orange County before the separation of the counties. He and some of his distinguished descendants are mentioned in Green's "Culpepper County History", page 83. Jeremiah made his will in Orange June 7, 1740, same probated 1741. He is said to have died at the age of 86, but it is nowhere shown whether this age is taken from a deposition, Bible or Wills. He bequeathed "to wife Eleanor, during her life or widowhood, all my estate real and personal... land to be sold and wife to have use of money during her life or widowhood. After death of wife or day of marriage, son CHRISTOPHER to have all of my estate whatsoever. Sons: JAMES, WILLIAM, FRANCIS, JEREMIAH and LAWRENCE Strother, and daughters CATHERINE and ELIZABETH to have one shilling each. Sons James and William to be exrs. Wits.: John Catlett, Francis Slaughter, Wm. Lightfoot. (W.B. 1, p. 141)

It is very probable that Eleanor his wife may have been a second wife if he died at the age of 86.

Francis Thornton and daughter of Anthony. It is of course quite possible that she had brothers who left descendants.

In conclusion I desire to acknowledge, with thanks, the assistance and advice given me in the preparation of this paper by Mr. W. Coulbourne Brown, of Philadelphia, a gentleman well versed in Savage lore and generous in sharing with others.

If disappointment may be felt in some quarters that our Anthony did not "Fight for King and Crown" (nor against them) let it be remembered that "Peace hath her Victories" also, and that through all the ages it has been men like Anthony Savage who have won them.



## ANTHONY SAVAGE

By WILLIAM BUCKNER MCGROARTY.

In Tyler's Quarterly, January, 1938, (Volume XIX)\* the writer presented what he thought was to have been his final contribution to the Anthony Savage Saga; the fact that he is writing again indicates that he was in error; instead of being at the end it appears that we are just beginning our investigation of the antecedents of Anthony Savage.

A generously helpful friend and correspondent who read the article above mentioned called attention to a most interesting book, long out of print a copy of which she had found in an old book-shop in Belfast, on a recent visit to Ireland; and she was kind enough to copy from this volume the genealogical record which, with her permission, is incorporated in the present article.

Fortunately a copy of the book<sup>1</sup> was available to the writer at the Library of Congress, in Washington and, since it is not generally accessible the writer is of opinion that a full description of its scope and purpose will be beneficial to many persons who are seeking a solution of the Anthony Savage problem, and that somewhat generous quotations from the context concerning the origin, rise and migrations of the Savage tribes will be found helpful and interesting.

"Of the ancient and noble family of the Savages, or, as the Normans wrote it, *Le Sauvage*—the first who came into these kingdoms passed from Normandy into England with the army of the Conqueror, A. D. 1066 and settled in Derbyshire. From Derbyshire the Savage family branched out into several English counties, and from Derbyshire, in 1177, they established themselves in Ireland, in the person of William Savage, one of the two Knights who fought De Courcy in the subjugation of Ulster and subsequently one of the Ulster Palatine Barons . . .

"In England the Savages became owners of extensive estates and became rich and powerful. In Ireland their sphere of activity was narrower than in England, but their position, relatively was no less eminent . . .

"Assisting the Ulster conquest William Le Sauvage won with his sword lands which for over seven hundred years have remained in the possession of his posterity . . . in the accounts of successive conflicts with the Irish of the North the names of his descendants figure conspicuously for centuries; as time went on, by conquest or royal gift the possessions of the Savages of the Ards increased until they became lords of territories wider than those of any other Ulster preditory, . . . but when Anglo-Norman Ulster became completely separated from the Pale, the Savages and their allies were practically isolated. Pressed upon all sides but the sea by the Irish hordes, under the leadership of their old enemies, the O'Neills in alliance with their old rivals in the Bissetts and the Macdonnells, they gradually lost their once firm grasp on their out-lying possessions. But in the Little Ards they were immovable."<sup>2</sup>

We must bear in mind that the book deals primarily with the Irish branches of the family; these, as time wore on, gradually lost their Norman characteristics and became increasingly Irish. The author, in his 'Prefatory Notes' says:

"The scantiness of public documents relating to certain periods of the

Savage Family history has rendered it impossible in some instances to obtain information which may hereafter be quite accessible when State Papers still lying out of reach of the ordinary reader have been calendered and printed . . .

"No attempt has been made to treat the history of the English and American branches of the Savages with fulness, and the compilers are aware that the list of American branches in particular is incomplete."

This of course is disappointing, not to say disconcerting; still, while far from complete an account of the English branch is given which seems to point the way for us; there is a fairly complete line of descent carried down from the original Thomas Le Suavage, the Norman, to Christopher Savage, "of Elmley Castle and of Upton, in the county of Gloucester, son of Sir Christopher Savage, of Upton, Knight, by his wife, Ann, daughter of Sir John Stanley, of Elford, Knight, and grandson of Sir John Savage of Clifton (Rock Savage), county of Chester, married Anne, daughter of Sir Richard Ligon".

The attention of the reader is now especially directed to the following record, prepared and sent to the writer by Mrs. Russell S. Barrett, who knows her Savages better than most of us do and who has done not alone the writer but genealogists in general a generous and important favor.

"Probably the English Antecedents of Anthony Savage, of Virginia."

Charles III, above, of "Tetbury, Gloucester, b. 1590, married 1610, Elizabeth, daughter of Anthony Abingdon; she died 1663. He (Charles) 1652, aged 62 years.

"It seems very probable that Anthony (a)'s son Anthony (d) or one of his grandsons, Anthony (b) and (c) was the Emigrant to Virginia.

"The English Anthony Savages, of which I send a copy, are of the right time, 16th century, and other items seem to fit in. Of course there is no absolute proof but it seems that it must be this family that gave us the Anthony Savage that has been such a problem as to his ancestry. I send it to you for what you may get out of it."

Well, the writer gets so much out of it that he wishes it might have come to hand ten years earlier. There is an elusive factor in historical and genealogical research, known as 'the internal evidence', which often adds a very considerable weight in proof or dis-proof. It is intangible, but it is there. Mrs. Barrett in her deductions sets it forth clearly in the present instance, and we are that much nearer the goal.

If the State papers in England, inaccessible in 1888, have been calendered and printed since then it may be possible now to secure the information so long desired. The thought is offered to those of our readers who may have opportunity to search the English records in the near future.

So much for Anthony. What about Rowland Savage, contemporary with Anthony, who registered his mark of cattle in Accomac county in 1671?<sup>\*</sup> It will be remembered that Alice Savage, daughter of Anthony who married Francis Thornton named a son Rowland, a new name among the Thorntons but one long and honorably borne among the Savages; not, however, the Savages of England but the Savages of Ireland, those of The Ards.

#### THE IRISH SAVAGES AGAIN.

Page 245: "Two separate branches of the Savages of (Castle) Ardkeen have been styled at different eras as of Ballygalget. The earlier families of the Savages of Ballygalget was founded by Rowland Savage, son of James Savage and grandson of Sir Roland Savage of LeCale, last Seneschal of Ulster of the Savage kindred. . . . In A. D. 1602 a Roland Savage (who died 1640) was pensioned for good service to the Queen; he married Catherine Magenness.

Their son, Rowland, succeeded his grandfather at Ballygalget, and was living in 1701; he was a Captain in the Army of King James II; he and many of his kindred who had devoted themselves to King James' service were attained by King William.

"With the attainder of Captain Roland Savage the earlier line of Ballygalget was swept out of its possession in the Ards, and it would be very difficult to trace the history of the various descendants of the outlawed proprietors. This Roland Savage was a Member of King James' parliament."

A foot-note, page 250, states, "See, 'Illustrations, Historical and Genealogical of King James' Army List, 1689, by John D'Allen—Dublin, 1855. In the Reports of Record Commission, Roll No. 2, anne., p. 389; we find the following. . . . "All their right and interest in, to, and out of the lands of Ballyfuneragh, Bar. Ards, County Down, the Estate of Rowland Savage Attainted; Enrolled 22 September, 1703".

In explanation of the name Roland, (p. 119) the following is given. "Roland or Rowland; In Irish *Raibilin*, as an approximation to Irish pronunciation: in A. D. 1383 a great battle was fought with the O'Neills in which Roland was slain; he was the first of the name, which came into frequent use in the Irish branch; this Roland's father was Henry Savage, Lord of Ardkeen."

From 1383 to 1703 the genealogical record of the Savages of the Ards shows an unbroken line of Rolands, or Rowlands. The name does not appear after the attainder and confiscation of the estates of Roland, King James' Captain; that is, in Ireland; the name does not appear at all in the English branch, nor does that of Anthony appear among the Savages of the Ards.

Of course the attainted Rowland, living in Ireland in 1701 could not have been the Rowland of Virginia in 1671. But, as we have seen there were many Rowlands in Ireland; more indeed than there were contemporary Anthonys in England; the writer clings to the belief that there was a connection, if not close relationship existing between Anthony and Rowland in Virginia, but realizes that this belief adds to the complexity of the case. Further research in England may solve the problem.

The book treats only in the briefest manner of the two American branches which it lists. The first relates to the Savage family of Massachusetts, of the English line; the other is styled "The Savages of The Neck", meaning Savage Neck on the Eastern Shore of Virginia; of the descendants of Ensign Thomas Savage, the account follows practically that carried in the article published in Tyler's Quarterly already referred to. The author states that Ensign Thomas Savage came from Chester.

#### SAVAGE ARMS.

"Six lions rampant, sable, three, two, and one, armed and langued gules, on a field argent": Symbolizing the forest life and war-like character of their former forefathers. Crest, A lion's jambe proper, rising out of a ducal coronet, or. Supporters, Dexter, A falcon billed, or. Sinister an Unicorn argent."

The meaning of the name, Le Sauvage, in its true acceptance would be 'Savage' or 'ferocious' but is accepted when designating a family as indicating that they are "of the forest", of countrymen.

The writer would solicit the aid of his readers in developing any records that may exist of Rowland Savage. Perhaps the available records of old Abingdon church, Gloucester County, may help.

MILLER

Captain Simon Miller (1642-1683) immigrated to old Rappahannock County, Virginia.

Issue by his first wife (name unknown):

Simon Miller Jr.; a daughter (name unknown); William; John; Mary; Isabella; Margaret; and Susanna.

Capt. Simon Miller married (2) Margaret, widow of John Prosser who died 1677, no known issue. After Capt. Miller's death, Margaret married (3) Hugh French, and (4) John Summer-ville of Westmoreland County.

Simon Miller Jr. of Richmond County, son of Simon Miller by his first wife, born ca 1665, died 1720, married and had issue: Jane, Eleanor and Simon Miller.

Simon Miller 3rd of Culpeper County, b.? died 1799. He married (1) name unknown, and had issue: Simon Miller 4th who died 1806; Benjamin Miller; Mary Miller (1737-1755) who married a first cousin James Hord (1736-1802) and had a son James Hord; Alice Miller (1739-1775) who married John Markham (1732-1804) and had a son Lewis Markham.

Issue of Simon Miller 3rd by his second wife Isabella Miller, a first cousin: Eleanor Miller, born 1742, who married Thomas Strother and moved to Kentucky; Eliza Miller who married Capt. William Richards of Culpeper County and had issue: William T. Richards, and Elizabeth Lewis Richards who married Capt. Thomas Humphreys, as previously shown.

Simon Miller 3rd., in a second will dated 1798, proved May 12, 1800, omitting others, favored his youngest daughter, Eliza Miller Richards (daughter of his second marriage). Simon and his second wife had spent their de-

clining years in the home of Capt. William Richards and Eliza (Miller). After the death of Simon Miller 3rd. who died shortly after his wife, a suit in chancery arose over the deceased's will, which was presented for probate by Capt. William Richards and in which the bulk of the estate was bequeathed to Eliza, his youngest daughter. Simon and his wife Isabella had lived for a considerable time with the Richards family, it having been agreed that if the Richards maintained them they would receive the bulk of their property.

A deposition of John Strode taken March 13 1804 in Culpeper County stated that Simon Miller was a "very aged, wealthy, and reputable man of this County of Culpeper". The deponent (aged 70) went on at some length to say that he recollected about 1780 Simon Miller gave the land and slaves now in dispute to Capt. Richards, and "the late Mrs. Richards informed me" also of this gift, being "for the great care and attention which she said Capt. Richards on all occasions paid to Mr. Miller's interest, to his person, and to his Lady who were both very old and in a manner destitute of any other cordial and affectionate relief".

James Hord (1736-1802), son-in-law and nephew of Simon Miller deceased, hotly contested the will. Many depositions were taken and in 1822 Thomas Humphreys, son-in-law and executor of Capt. William Richards, was named a party to the suit, which seems to have been finally settled in the Richards' favor.

dated Feb. 16, 1679, he says he is "aged seaven and thirty yeares or thereabout". He probably came to Virginia about the year 1673, as he patented 817 acres of land in old Rappahannock County Nov. 5, 1673 for the transportation of sixteen persons into the colony.

In Doctor Philip A. Bruce's "Economic History of Virginia" Vol. II p. 439 he is mentioned as one of the noted shipbuilders of colonial Virginia, the possessor of considerable estate, and as having "bought 625 acres of land in one tract." The fact that he was a ship-wright, considered in connection with the following notices relating to his family, suggests that his home before coming to Virginia might have been Bristol, England, one of the most important ship building ports at that time in Great Britain:

In Deed Book 9—1696-99, p. 333 of old Rappahannock County "John Miller of the city of *Bristol* Mariner appoints Captain Arthur Spicer of the county of Richmond Gent. and Thomas Gregson of the county of Essex attorneys for me at the General and County Courts in any case wherein I may be concerned" 15 Sept. 1698. This "John Miller, Mariner" was probably the son who is mentioned in Captain Simon Miller's will, as he had property interests in Essex County where the children of Captain Simon Miller resided.

Deed Book 1724-26 Essex Co. pp. 208, 209 "Noblet Ruddock of the City of *Bristol*, Merchant, Attorney of Lucy Fflower, widow, mother of Jeffrey Fflower late of Virginia deceased — — — I have to these presents set my hand and seal in the *city of Bristol* in Great Britain 12th year of the reign of our sovereign Lord George etc. 1723." Witnesses: King Bird, George Taylor, *Simon Miller*. This paper was signed and witnessed in *Bristol, Great Britain* and Simon Miller one of the witnesses was certainly residing at that time in *Bristol*. (The tomb and arms of "Jeffrey Flower deceased" are in Abingdon Churchyard, Gloucester Co., Va. Va. Mag. Vol XI, p. 71).

Deed Book Essex Co. Va. 1723-33 p. 206 "Power of Atorney from Johnathan Lambert, Mariner of the City of *Bristol* in Great Britain, to my well beloved friend Simon Miller of Essex Co. Va." These items seem to indicate that the Miller family in Essex County Va. had a connection with Bristol.

Captain Simon Miller married Margaret Prosser, widow of John Prosser of "Golden Valley", whose will was proved in old Rappahannock County June 30, 1677.

Captain Simon Miller's will was dated Feb. 16, 1679 and was proved in old Rappahannock County, May 2, 1684. He directs that "in case I dye my son Simon be sent *home* the next year to *England*." He bequeaths large tracts of land to his children, mentions his wife Margaret Miller and makes bequests to the "Sons of Mr. Prosser" his wife's first husband. Witnesses of the will—Francis Thornton, James Taylor, Nathaniel Tomlin.

The original will of Captain Simon Miller is still preserved in the Clerk's Office of Essex County. Attached to this will is a wax seal with impressions which are not distinct.

7. Susannah Miller married Henry Brice and her will dated Nov 24, 1724 was proved in Essex Co. January 19, 1724 (old style). No children are mentioned in her will but she refers to her husband who was deceased (His will dated March 29, 1722, was proved Sept. 11, 1724 in Essex County. He mentioned wife Susanna). Susannah (Miller) Brice makes bequests in her will to "my brothers John Miller and William Triplett and my cousins (nieces) Jane Miller, Eleanor Elliston, and (her nephew) Daniel Triplett." William Triplett was the husband of her Sister Isabella and father of Daniel Triplett. Jane Miller (later wife of Thomas Hord) and Eleanor Elliston were daughters of her brother Simon Miller.

2. Simon<sup>2</sup> Miller (Captain<sup>1</sup> Simon) was at some time a resident of Essex County. January 14, 1692 "Simon Miller of Essex County makes a gift to Thomas Parker, School Master" (Records of Richmond County). He was later a resident of Richmond County in which his father left him an estate: was witness to the will of Robert Pannill, dated March 16, 1716, proved in Richmond County, and witness to the will of Hugh French, proved in Richmond County December 3, 1701.

Simon Miller's will, dated December 1, 1719, was proved in Richmond County, May 4, 1720. In it he mentioned the following children:

8. Eleanor Miller married Mr. Elliston. She is mentioned in the will of her Aunt Susannah Brice proved 1724. There is reason to believe that she has many descendants but their names are unknown to the compiler.

9. Jane Miller married June 24, 1726 Thomas<sup>2</sup> Hord (John<sup>1</sup>). June 20, 1727 in Essex Co. a suit of "Thomas Hord and Jane his wife against John Miller and William Triplett" caused by the will of Susannah (Miller) Brice. See also Journals of House of Burgesses 1727-37: 1736-40 pp. 132, 133, 135. They left numerous descendants.

10. Simon Miller.

4. John<sup>2</sup> Miller (Captain Simon<sup>1</sup>) was a resident of Essex County and there are many references to him in the Order Book of that County. He served on a jury September 19, 1723, and on the Grand Jury in 1724. He was probably the "John Miller, Mariner" sometime of Bristol, England, mentioned above. He was probably the Captain John Miller, commander of the ship "Sarah" bound for Virginia, mentioned in the will of "John Payton of Ham Green, Parish Porthry, Somerset, England, being sick on board ship" proved Aug. 4, 1699 (Va. Mag. Vol. XII, p. 177). He was one of the executors of the will of his sister Susannah (Miller) Brice. This will was the cause of a long chancery suit brought by Thomas Hord and his wife Jane (Miller) Hord (see order Book, Essex Co., 1725-29, page 241).

John Miller's will dated April 15, 1742, proved in Essex County December 30, 1743. mentions his wife Mary and the following children:

Simon<sup>3</sup> Miller (Simon<sup>2</sup>, Captain Simon<sup>1</sup>) married October 2, 1740 Isabella Miller who might have been his cousin Isabella (16), marriage record in Overwharton Parish Register. He removed to Culpeper County and there is a deed of gift September 17, 1767 from "Simon Miller and Isabella his wife of Culpeper County to James Hord" son of Jane (Miller) Hord (see Culpeper records).
